Job Title: SPEECH-LANGUAGE PATHOLOGIST (Part-Time Position)

Organization: Speech & Hearing Center of the Mid-South dba Memphis Oral School for the Deaf (MOSD) is a non-profit organization that aims to Empower Deaf Children to Listen, Learn and Talk. MOSD is an early education intervention auditory-verbal clinical educational program focusing on developing listening and spoken language skills (LSL) in children who are deaf and hard of hearing. MOSD has four different programs to serve clients: Sound Beginnings (age 0-2), Sound Transitions (age 1.5-3), Sound Voyagers – Language Development program for hearing children (age 3-4), Sound Plus – Total Communication Program for children on the spectrum (age 3-4), MOSD Pre-School (age 2-5), and Outside Clients (All ages).

EDUCATION and **EXPERIENCE**: Master's Degree, Certificate of Clinical Competence from ASHA, and Valid State License (or ability to file for one). *Preferred—Experience with Listening and Spoken Language strategies and techniques. If you have no experience, you MUST be willing to learn.

Job Description: The Part-Time Speech-Language Pathologist at the Speech and Hearing Clinic of the Mid South, operating as MOSD, conducts speech evaluations and provides speech and language therapy services in a clinical setting, working an average of 24 hours per week.

Primary Functions:

- Conducting Assessments: Perform comprehensive speech and language assessments for clients, including evaluating speech production, language comprehension, and communication abilities.
- Developing Individualized Treatment Plans: Collaborate with clients and their families to develop personalized treatment plans tailored to their specific needs and goals.
- Providing Therapy Sessions: Deliver evidence-based speech and language therapy interventions to address
 areas of difficulty, such as articulation, phonology, expressive and receptive language skills, pragmatics, and
 fluency.
- Enter appropriate clinical notes into the clinical system promptly.
- Monitoring Progress: Regularly monitor client progress and adjust treatment plans to ensure optimal outcomes.
- Providing Parent Education and Support: Educate parents and caregivers on strategies to support their child's communication development at home and in other environments.
- Collaborating with Multidisciplinary Team: Work closely with other professionals, including teachers, audiologists, and occupational therapists, to coordinate care and ensure holistic support for clients.
- Determining Caseload: Work with the supervisor to determine an adequate caseload.
- Continuing Education and licensure: Completes continuing education for licensure, CCCs, and professional development.
- Other: Participate in staff In-Service sessions when they occur.
